CONDITIONS OF BOND

1. That the Obligor must work in the country upon completion of the said training as a _____ or in such capacity as the Government may direct for a period of _____ or such shorter period as the Government may determine calculated from the completion of the said training;
2. If the Government is unable to offer the Obligor employment or, at its discretion, the Obligor may seek alternative employment with a statutory body, public corporation, private company, or any other local institution within the Fiji Islands with the prior approval of the Government and the conditions set out in paragraph 1 hereto applies *mutatis mutandis* to such employment. This paragraph does not apply to In-service scholarship who must immediately return to the employment of the Government of Fiji after completion of their studies;
3. If the Obligor does not serve the country of the Fiji Islands for the period referred to in paragraph 1, or if the Obligor does not serve the country as per paragraph 2, then the Obligor must pay to the Government in one single payment, an amount not exceeding the total amount of the above-written bond as the Government may determine in its discretion under this bond, together with interest at the rate of 10% per annum;
4. If the Obligor wishes to invoke paragraph 3 for the purposes of migration or otherwise, the Obligor is liable to pay to the Government the sum owing, in a single payment prior to migration or in undertaking a course of action which prevents the Obligor from fulfilling his or her obligations under this bond; and
5. If the Obligor's scholarship is terminated due to his or her own negligence and/or misconduct prior to completion of studies, the Obligor is liable to reimburse the Government the total sum spent, by reason of this Bond, as at the date of termination.

But in the event of my failing to fulfil the above-mentioned conditions where applicable, the above-written bond shall remain in full force and effect notwithstanding no demand be made by or on behalf of the Government of Fiji.
